HRH CROWN PRINCE AL-HASSAN IBN TALAL PATRONIZED IAS-AL AL-BAIT FOUNDATION JOINT SEMINAR


Under the Patronage of HRH Prince Al-Hassan, Crown Prince of the Hashemite Kingdom of Jordan, the Seminar on "Coordination and Cooperation Among Institutes of Research and Studies and Their Applications Within Framework of Islamic Thought" jointly organized and sponsored by IAS and the Royal Academy for Islamic Civilization Research (Al Al-Bait Foundation) was held in Amman during the period 20-21 Thu-Al-Quidah 1409 H, corresponding to 24-25th June 1988.

In His Highness's inaugural address read by H.E. Prof.Dr.N.Al Asad, Minister of Higher Education and President of the Royal Academy for Islamic Civilization Research (Al Al-Bait Foundation), HRH Crown Prince Al Hassan Ibn Talal emphasized the urgent need for a dialogue between Islamic institutes as a pre-requisite for accomplishing coordination and cooperation and reaching balance between theoritical and humanities' sciences on one hand and applied sciences on the other. HRH called upon participants to establish a well defined plan for common projects and activities with specific mechanisms for implementation to achieve objectives within the framework of a joint Islamic effort to help the Muslim Ummah gain its glory.

In his opening statement, H.E. Prof. Dr. M. Kazi, President of IAS, expressed gratitude for HRH Crown Prince Al-Hassan for patronizing the Seminar, the idea of which was initiated by HRH the Crown Prince. Prof. Kazi said that Islam is the religion of knowledge and research and has all the incentives for believers to study, explore and utilize research results for the benefit of the Ummah and humanity at large.

Thirty eight persons representing fourteen organizations and institutes from within and outside the Muslim World took part in this activity which was the first of its kind. Fifteen papers, twelve of which were institution's papers were presented and discussed. The papers and discussions were based on a rational paper previously prepared by the Organizing Committee in which the objectives of the Seminar were outlined.

The discussions were focused on ways and means of enhancing coordination and cooperation among Islamic institutes and opening dialogue channels on the crucial issues facing the Ummah. In their

final report the participants emphasized the following domains as priority areas for cooperation and coordination:

- Development of S&T capability of the Ummah.
- Research on Islamic economics with emphasis on issues of direct interest for the Muslim masses.
- Issuing of a high quality Journal in several languages as a forum for studies and research on Islam and the Muslim World.
- Executing research projects which need the efforts of various groups in different Islamic countries such as encyclopedias, bibliographies ...etc.
- Translation of literature on Islamic legacy into several languages to enhance spreading Islamic thought through out the world.

Exhange of publications, scientific visits and organization of joint conferences and seminars.

The two day seminar was concluded by issuing a set of recommendations calling upon all Islamic institutes of research and studies to work jointly within a framewrok of coordination and cooperation as a step on the course of Islamic unity. A working-group committee was formed to follow-up the outcome of the seminar and to prepare a field study on the Islamic institutes, their potential and specific projects and programmes that can be jointly undertaken.

The working-group comprised Al Al-Bait Foundation (as Secretariate), Islamic Academy of Sciences, International Institute for Islamic Thought (Washington), King Faisal Centre for Islamic Research and Studies (Riyadh), Abdul-Hamid Shouman Foundation (Amman) and Research Centre for Islamic History, Art and Culture (Istanbul).

IAS was well represented in the Seminar. Both Dr. A. Kettani and Dr. M. Qurashi, IAS Fellows presented papers and Dr. M. K. Mahmoud and Dr. F. Daghestani participated in the seminar and headed working sessions. Dr. Daghestani was chosen Rapporteur of the Seminar.

IAS COUNCIL HELD ITS 6TH MEETING

The 6th meeting of IAS Council was held at the Academy's head-quarters in Amman on the 22nd, June 1989. Six Council members participated in this meeting.

The Council discussed and approved several issues on its agenda. Acting Executive Director General (AEDG) presented a report on the

activities of IAS headquarters and future plans.

The Council deliberated at length on the financial status of IAS and ways and means of Securing funds for IAS programme. The Council decided to initiate direct contacts with the private sector and potential contributors through out the Muslim World aiming at exposing the Academy, its objectives and programme to encourage these parties to financially support IAS.

One other major issue on the agenda of the Council was IAS Scientific Journal. Appreciating the progress of the Journal, the Council affirmed its stand that the Journal should continue as a distinguished publication and a forum for muslim scientists.

The Council also reviewed the arrangements for IAS 1989 conference to be held in Kuwait. Election of new fellows for the Academy for the year 1989 was discussed in light of previous resolutions of IAS General Assembly. The Council approved a

procedure for promoting fellowship of eminent muslim scientists from Islamic Countries which are not represented in IAS.

Dr. BILBEISI APPOINTED EXECUTIVE DIRECTOR GENERAL OF IAS

In its 6th meeting, IAS Council considered the filling of the vacant position of the Executive Director General (EDG) of IAS.

The candidature of Dr. Anwar Bilbeisi was presented to the Council who decided to offer him the position of EDG on contract basis. The Council authorized Dr. Daghestani Treasurer of IAS to prepare and sign the employment contract of Dr. Bilbeisi on behalf of IAS Council.

Dr. Bilbeisi who assumed his new assignment as of August Ist, 1989, is a Urologist who abtained his M.B at Cairo University in 1957 and a Diploma in Urology at London University in 1962.

Prior to Joining IAS. Dr. Bilbeisi held many high positions, the last of which was the position of Secretary General, Ministry of Health of Jordan. He was also

involved in several activities such as heading rescue teams to disaster areas in Sudan, Algiers and North Yemen. Dr. Bilbeisi is also a member of several governmental and private committees and boards as well as a member in several professional bodies. He was awarded two Royal Medals, Alkawkab in 1988 and Alnahdah in 1989.

The editor takes this opportunity to congratulate Dr.Bilbeisi on his new assignment and whish him every success.

ELECTION OF NEW FELLOWS

In accordance with the By-laws of the Islamic Academy of Sciences, election ballots for IAS fellowship for the year 1989 have been forwarded to all IAS fellows to exercise their right of election. The voted ballots should reach IAS Secretariate, no later than the first of October 1989.

Twenty three IAS Fellows exercised their right of nomination and (20) muslim academician and scholar were nominated for IAS fellowship for the current year of whom (10) persons shall be elected by the existing IAS Fellows.

EDITOR'S LETTER

The Muslim Ummah is facing numerous challenges in many areas. Combined with the prevailing conditions in the Muslim World, this situation necessitates solidarity and cooperation at all levels. Realizing this fact, Islamic learned institutes carry a historical responsibility in taking initiatives to lay grounds for a joint Islamic action that would meet the expectations of the Ummah.

The organization of the seminar on "Coordination and Cooperation Among Institutes of Research and Studies and their Application within the Framework of Islamic Thought" by IAS and Al Al-Bait Foundation, represents a committed step in this direction. The main objective of the seminar was to get closer Islamic institutes and muslim scientists and scholars to know of each other's areas of interest, potential and programmes. Part of our problem in the Muslim World is that we know very little about each other and it is prime time that we open wide the door for a fruitful dialogue on mechanims of coordination and cooperation.

One other important objective of the seminar was to bring together muslim scientists and scholars of the two major disciplines "nature and religion" to deliberate on ways and means of helping the muslim masses to deal with contemporary issues the list of which is getting longer day after day.

The recommendations of the participants-reflect the genuine intention of allparties whether institutes or individuals to coordinate and cooperate as it reflects the deep interest of all participants in initiating a joint Islamic action that cover a wide range of activities with the aim of promoting the capability of the Ummah in various fields specially science and technology as well as giving the concept of "Unity of the Ummah" it real dimensions.

IAS COUNCIL AND G.A. MEET IN DECEMBER

IAS Council has decided in its 6th meeting to hold the next IAS Council and General Assembly meetings in Kuwait following IAS 1989 Conference (2-5 December 1989).

Several important issues will be on the agenda of the G.A. including the approval of election results and induction of elected fellows. Promotion of IAS financial resources and implementing its programme will take major part of the deliberations. The G.A. will have aslo to decide on the theme, venue and date of IAS next conference.

IAS AND ISESCO SIGN COOPERATION AGREEMENT

In conformity with their objectives and programmes, the Islamic Academy of Sciences (IAS) and the Islamic Educational, Scientific and Cultural Organization (ISESCO), have signed a cooperation agreement aiming at developing harmonious and continuous collaboration between them.

The two organizations have agreed to grant each other access and facilities to all data, documents and studies and to provide each other with every assistance in the form of saff activities or services. The two parties according to the agreement, may agree upon complementary arrangements to improve or develop particular aspects of their cooperation.

The two parties have also agreed to invite each other's representatives to sessions of general assemblies, conferences and symposia.

The agreement was signed by Prof. M. Kazi President of IAS and Prof. A. Boutaleb, Director General of ISESCO.

ORGANIZING COMMITTEE FOR IAS 1989 CONFERENCE MEETS IN SEPTEMBER

The Organizing Committee for IAS 1989 Conference on "New Technologies and Development of the Muslim World" jointly organized by IAS and Kuwait Foundation for the Advancement of Science (KFAS) will meet at IAS headquarters in September 1989.

The Committee which comprises representatives of IAS and KFAS shall review the progress in the arrangements for the conference and finalize organizational matters.

The Conference which shall be held during the period 2-5th December 1989, will include the presentation and discussion of fourteen papers in specific areas of new technologies as well as commentry papers on the potential of the Muslin World in these areas.

In addition to the 49 IAS Fellows, about 100 Scientist, academician and technologist are expected to participate in the Conforence.

IAS is expected to issue a declaration addressing decision makers, planners and the scientific community and calling for the adoption and adaptation of new technologies relevant to the development of the Muslim World and taking immediate measures to promote the Ummah's capability in the areas of new technologies.

HIGHLIGHTS OF RESEARCH ACTIVITIES AND POTENTIAL OF ISLAMIC INSTITUTES:

H.E.J RESEARCH INSTITUTE OF CHEMISTRY, UNIVERSITY OF KARACHI

Research

A number of nationally and internationally funded research projects are being conducted in the Institute. During the year 1988-89, the institute has had 143 research papers published (or accepted for publication) in leading international journals, which is an indication of the growing momentum of the research activity in the Institute. The researches include the development of a marine alkaloid active against the AIDS virus (Prof. Att-ur-Rahman's research group) for which a contract for development has been concluded with Hoffman La Roche, New Jersey, USA, a new analgesic (Prof. Atta-ur-Rahman's research group) for which a contract has been concluded with N/S. Reckitt & Coleman, U.K., and a new immunomodulator (Prof. Attur-Rahman, Dr. N.S. Shekhani & DR. Mrs. Shahana Kami) for which a contract is being negotiated with a number of companies. A proteolytic enzyme has been isolated as a part of contract research with K/S. Ghani Sons (Pvt) Ltd. involving neutral proteinases for leather finishing (Prof.Z.H. Zaidi's group).

Studies on various plant materials, Azadirachta Indica (Neem), Melia Azaderach (Bakayan), Peganum Harmala, Nerium Oleander and Plumerial Obtusa, have resulted in the isolation of a series of new constituents. Apart from their structural studies, they have been subjected for their pharmacological screeing and some of the new constituents have been found to possess significant biological activity such as anti-cancer, CNS depressant and antibacterial. Further studies in this direction are in progress. On the other hand, various factors and uniform constituents of Neem have been tested for their pesticidal properties. Some of them have been found to possess insect growth regulating properties against house-flies mosquitoes whereas some other fractions were found to be growth regulators against stored-grain insects (Prof. Salimuzzaman Siddigi and Dr. Bina Shaheen Siddiqi's group).


